WATER:	One 60 HP turbine pump and well with installation completed in January of 2015. Well depth is 400± feet with 14" steel casing, gravel packed. Bowl assemble is set at 360± feet. Well and pump installation report are available upon request. One new 400± foot deep domestic well with 1.5 HP variable speed pump


