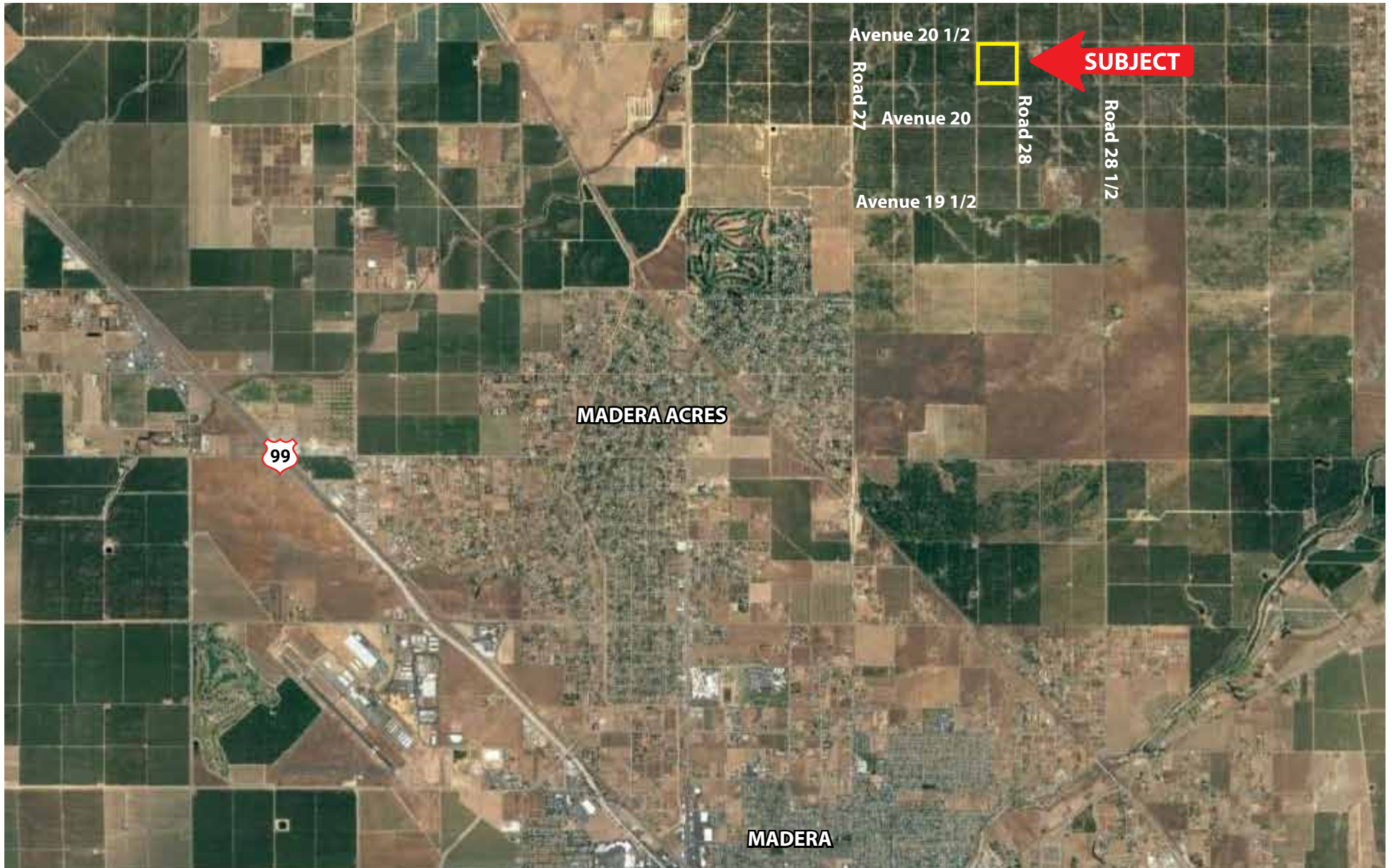

LOCATION:

Subject property is on the South side of Avenue 20 ½ and east of Road 28. Approximately ¾ of a mile east of Road 27 and ½ a mile west of Raymond Road. Property is 2 ½ miles northeast of the city of Madera.

DESCRIPTION:

Approximately 40.32± acres with income producing pistachios. The original orchard was planted in 1974.

LEGAL:

Madera County APN's: 031-101-006. Located in a portion of Section 19, T10S, R18E, M.D.B.&M.

PLANTINGS:

Kerman variety planted in 1974 on Atlantica Rootstock. Since then, replants have been planted to Kerman on UCB-1 Rootstock.

Madera Water District. Property is irrigated with a mini-sprinkler irrigation system. Property is within the Williamson Act.

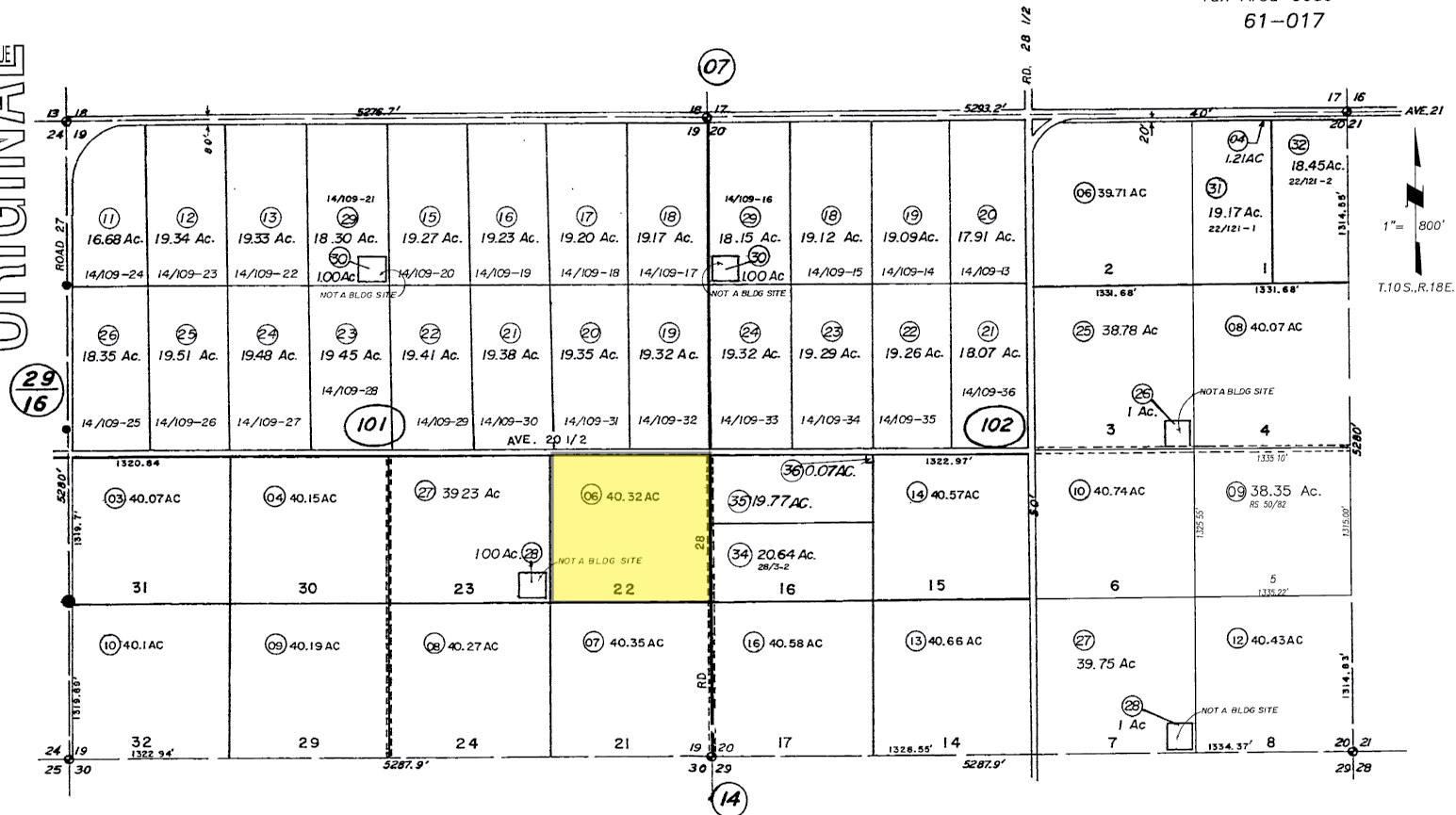
