



### PROPERTY INFORMATION

### DESCRIPTION

The property is comprised of 46.77± accessed acres and includes 45± acres of young almonds within the Fresno Irrigation District. 4th leaf almonds are just coming into production providing future income during the transitional development time of the property. The Fresno City Limit is one-half mile west of the property, along with being within the Sphere of Influence, Southeast Development Area, and the Clovis Unified School District.

#### LOCATION

Located on the east side of N. Locan between E. Belmont and E. Tulare Avenues, the property can be accessed from both Locan and Tulare Avenues. The Freeway 180 and Temperance Avenue on/off ramps are within ¾ of a mile from the property. Physical address: 7760 E. Tulare Avenue, Fresno, CA 93727.

### ZONING

The property is zoned RR - Rural Residential within the County of Fresno. The General Plan shows the property is designated as "Residential-Low Density". The property is not located within the Williamson Act.

#### PLANTINGS

The property was planted to almonds in 2020, consisting of Nonpareil and Bennett Hickman varieties (50%/50%).

### SOILS

The soil consists of predominately Grade 2 – Good rating soil. See Soils Map included.

### WATER/IRRIGATION

The property is located within the Fresno Irrigation District and currently receives surface water via the canal that borders a northern portion of the property. There is a 25 HP irrigation pump and well and sand filtration system for delivery of orchard irrigation water through a dual-line drip system. There is also a domestic well currently not in use.






### **SOILS MAP**
