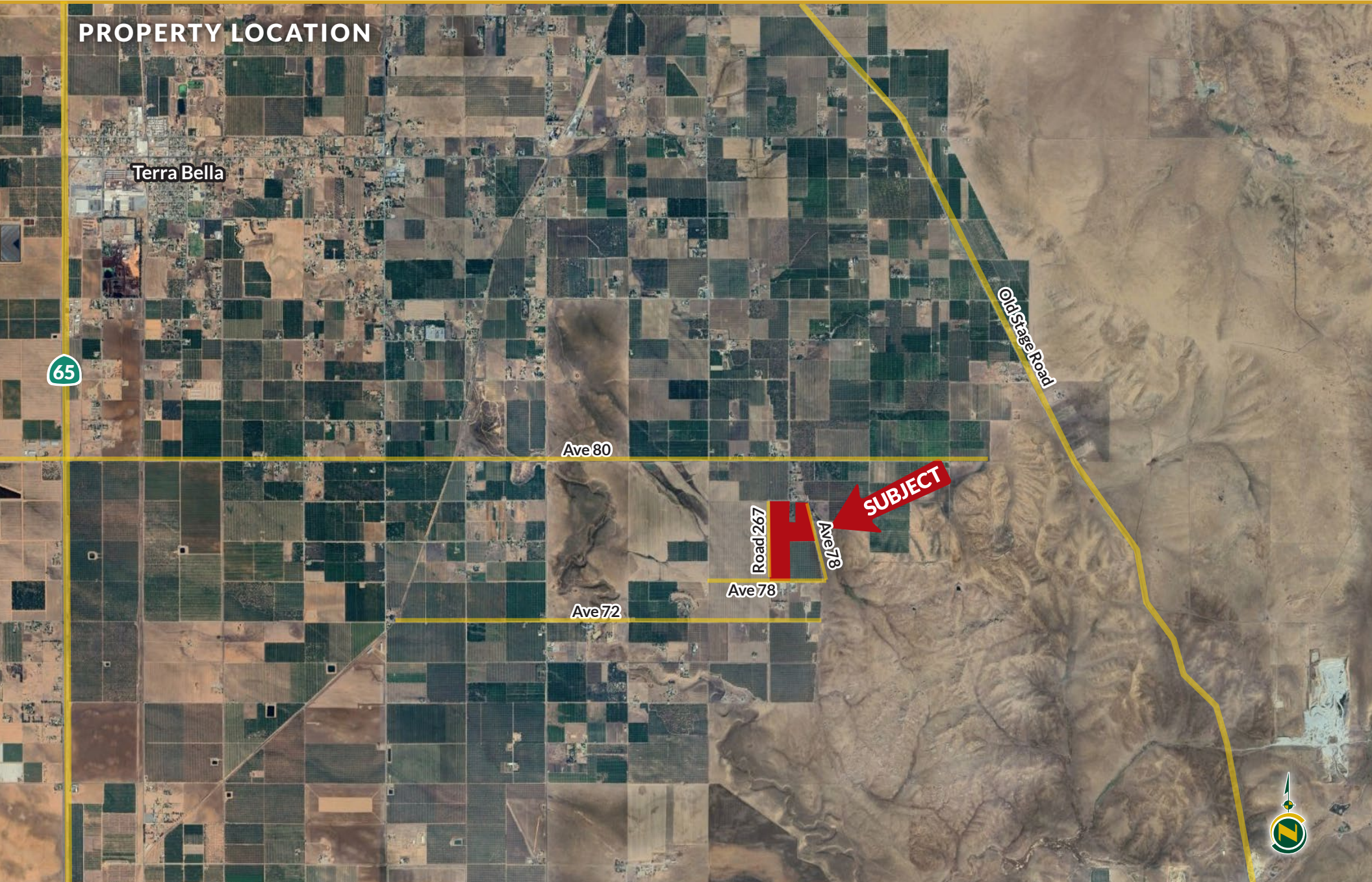

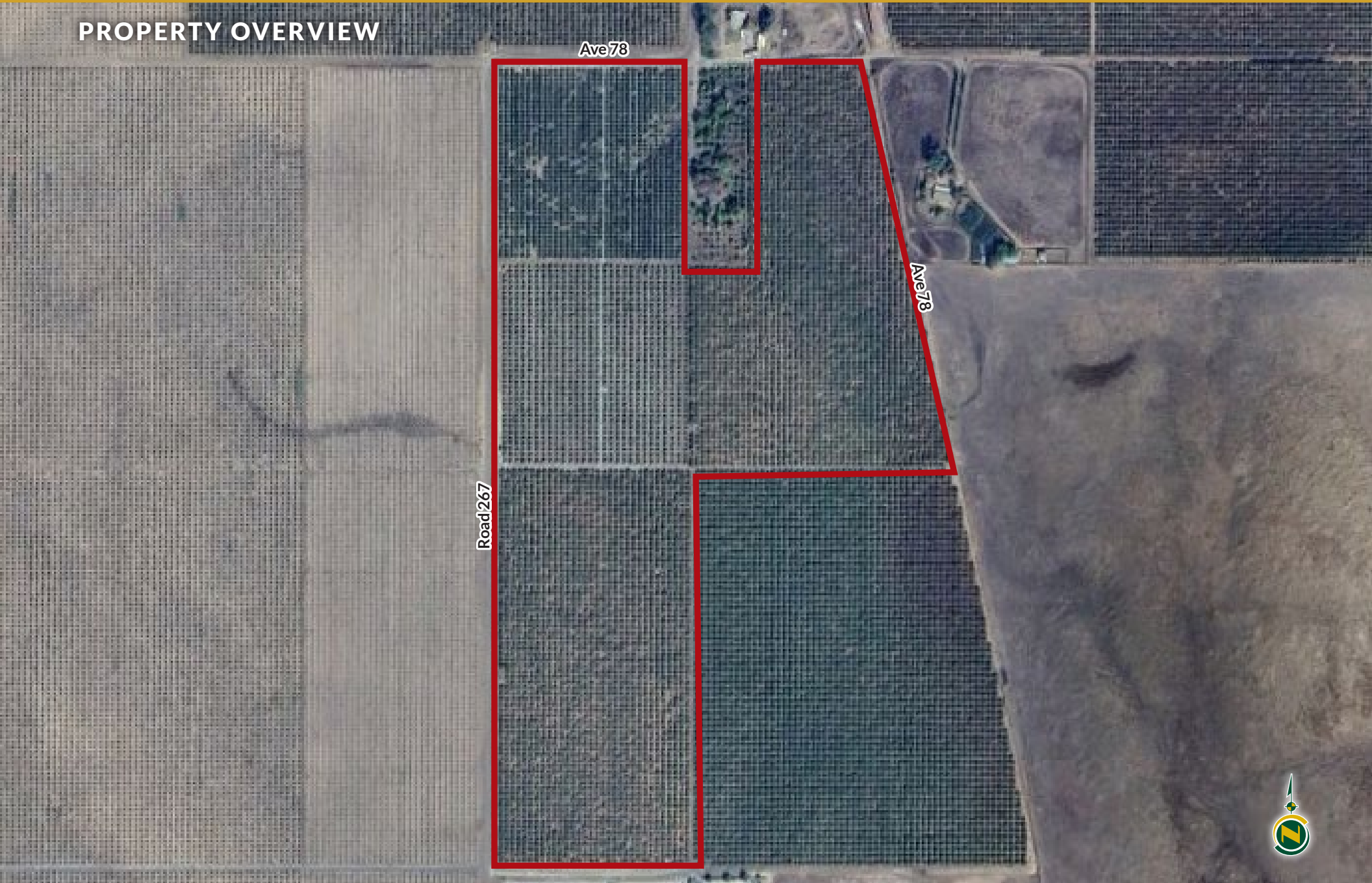

SOILS MAP



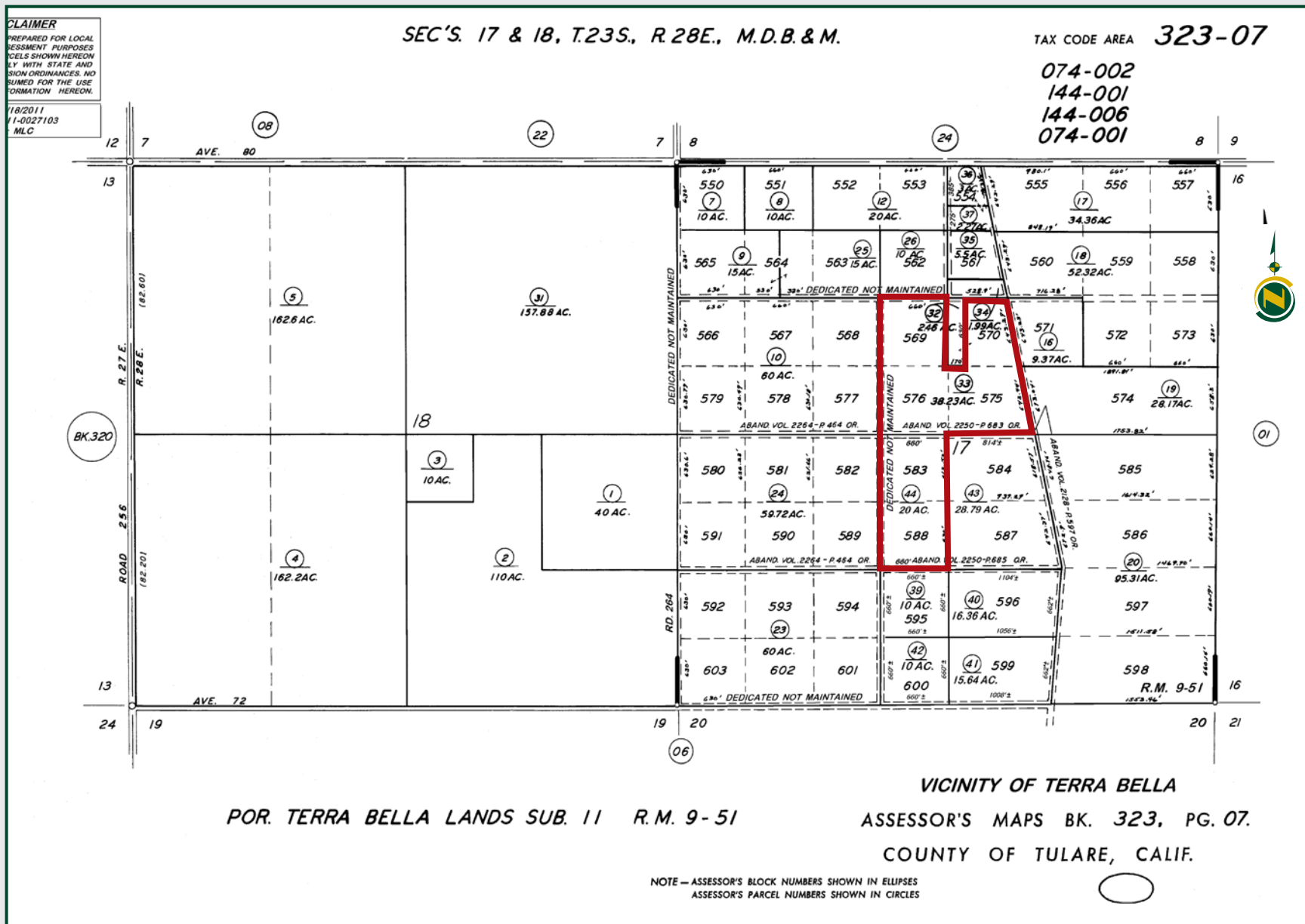
